



## REGULATIONS

about the World Cup Unifight among men and women  
(September 16-21, 2019, Ukraine, Odessa region, Chernomorsk)

### 1. Goals and objectives

- • further popularization of the “Unifight” and expansion of the geography of the participating countries;
- • Strengthening international sports connections and exchange of experience between national federations;
- • identifying the strongest athletes in the world according to the “Unifight”
- 

### 2. Organization, time and place

The Cup is held from September 16 to 21, 2019.

The address of the competition: Ukraine, Odessa region, Chernomorsk, Mira Avenue, 20, Palace of Sports "Youth".

Competition program:

16 of September:

- referees seminar, certification and accreditation of referee of national federations for fights in the championship;
- 10.00 - arrival of teams, accommodation;
- 15.00 - 17.00 - the credentials committee, weighing, drawing;
- 17.00-18.00 - a joint meeting of the Organizing Committee, the panel of referees and team representatives. At the end of each day of the competition, a meeting of the panel of referee and representatives of the teams is held.
- 18.00 - 19.00 - official training on the obstacle course.

September 17:

- 10.00-12.30 - the beginning of the preliminary fights on the unifight (light section) among men and women;
- 1:00 pm - solemn opening of the World Cup in unifight among men and women;
- 13.30 - the continuation of fights in the unifight (light section) among men and women fights are held to determine the finalists.

September 18:

- 10.00 - final fights in the unifight (light section) of men and women;
- 13.00 - Awarding of winners and prize-winners in the unifight (light section) among men and women.
- 14.00-16.00 - Mandate Commission, weighing, drawing on the unifight (classic section) of men and women.

September 19:

- 10.00 - the beginning of the preliminary fights on the unifight (classic section) among men and women;
- 1 pm - 2 pm - lunch;
- 14.00 - continuation of fights in the unifight (classic section) among men and women, fights are held to ½ finals.

September 20:

- 10.00 - semifinal fights in unifight (classic section) among men and women;
- 1 pm - 2 pm - lunch;
- 14.00 - continuation of fights in unifight (classic section) among men and women. Fights are held before determining the finalists.

September 21st:

- 10.00 - final fights in unifight (classic section) among men and women;
- 13.00 - awarding the winners and prize-winners of the classic unifight, the official closing of the championship; departure of participants.

### 3. Management of the World Cup

Overall management of the World Cup is entrusted to the Organizing Committee. Direct management of the competition is carried out by the main panel of referees. The referring of the Cup is held in accordance with the Rules of the Universal Fight competition, approved at the FIAU Congress.

Head Referee of the Cup - by appointment

The main secretary of the Cup is Zviahintsev Ihor, the referee of the international category "B" class (Ukraine).

#### **4. Participants of the competition:**

- Men (18 years and older) - 9 weight categories: 60, 65, 70, 75, 80, 85, 90, 95, 95+ kg.

- Women (18 years and older) - 7 weight categories: 48, 52, 57, 63, 70, 78 and 78 + kg.

The sports delegation includes: 1 head, 1-2 coaches, 1 referee and other officials by decision of the President of the National Federation.

To participate in competitions in the Unifight in the light section, athletes can take part, which belong to an early age category, in the case of a high level of general physical fitness and excellent health.

Athletes uniform (unifight): red and blue kimonos, open-toed hand gloves with the Unifight emblem, boxing helmet with the Unifight emblem, wrestlers with soft sole without edging, shin pads and foot elevation, protective shell, burl, sneakers to overcome the obstacle course. Helmet and gloves should match the color of the kimono. Protective gear should be under kimono. For women, additional special bibs. Each team must have at least 2 certified knives "Unifight", an air pistol of the established sample.

The uniform of the judges: black pants, white shirt, black butterfly, soft black sports shoes, black socks, red - blue sleeves.

#### **5. The conditions of the competition for Unifight (classic section)**

The procedure for the draw and the procedure for conducting fights is established (after the credentials committee and weighting) by the jury, depending on the number of participants in each weight category.

5.1. Obstacle course: a knife throwing from a distance of 3 meters and shooting at a target (inflatable ball) from a pneumatic weapon from a distance of 15 meters enters an obstacle course. A miss of an athlete at a target when throwing a knife or shooting is punished by overcoming an obstacle that precedes the line of shooting and throwing of a knife (usually a "pipe"). If at the same time the opponent hits the target, then he (the opponent) is awarded 1 point in the second round (for throwing and shooting separately). An athlete who finished first in the obstacle course with a difference of more than 10 seconds will receive an additional premium score of 1 point, which will be credited to him in the 2nd round; every additional 5 seconds, the advantage is awarded an additional 1 point.

If the contestant who finished second is behind the first contestant by more than half of his time in the runway, he is removed from the competition, and his opponent is awarded a clear victory. The winning streak counts for one won round.

5.2. Fight in the ring: in the preliminary fights in the ring - 2 rounds of 2 minutes of pure time, in the semifinal and final fights - 4 rounds of 2 minutes of pure time (for juniors and men). The break between rounds is 1 minute. For boys, girls, juniors and women 2 rounds of 2 minutes of pure time at all stages of the competition

Competitions are held on the Olympic system with the elimination after the first defeat.

- If there are 3 or 4 participants in the weight category, then the competition in this weight will be held in a round robin.
- If in two, following one after another, the weight categories are 1-2 people each, then they can be combined into one - heavier weight category. Such a decision on the eve of the draw must be made and approved by the protocol of the joint meeting of the championship panel of judges and the leaders of the sports delegations of the countries participating in the Championship.

#### **6. Conditions of the competition for universal combat (light section)**

Competitions for lightweight Unifight are held as a biathlon:

6.1. When passing an obstacle course, an athlete who finishes first with a difference of more than 10 seconds will receive an additional premium score of 1 point, which is credited to him in the 2nd round, with an additional 1 point advantage every subsequent 5 seconds.

If the competitor who finished second is behind the first by more than half of his time in the runway, he is removed from the competition, and his opponent is awarded a clear victory.

6.2. The fight in the ring is carried out using various methods of struggle.

In competitions according to the rules of Unifight (light section), the fight in the ring is held only standing, without a fight lying down.

The victory is awarded to an athlete who has managed to first hold a clean throw of an opponent on his back, or who has collected more points for throwing on his side, belly, chest, buttocks. Throws on knees, knee, hands, hand are not counted. After the throw, athletes are lifted to the rack and the round continues.

If an athlete makes a clean shot - any throw on the back, the fight ends and a clear victory in a fight is awarded to him.

In the event that the athlete failed to hold the estimated throws from the wrestling position in the allotted time for the fight in the rounds - both standing and trying to hold throws both athletes fall into the ring at the same time on the stomach, side, or other body parts defined by the rules, the judge in the ring after agreeing with side judges determines the more active athlete and announces his victory, according to the judges.

The overall victory in the biathlon is awarded to the athlete who won the early victory in the obstacle course or in the fight in the ring, and if this did not happen - won 2 rounds out of 3.

If the athlete wins the first 2 rounds - on the obstacle course and the first round in the ring, the fight ends and he is awarded a victory.

At all stages of the competition (preliminary, in the semi-final and final fights) fights on tatami - 2 rounds with 2 minutes of pure time. The break between rounds is 1 minute.

### **7. Determination of winners**

The winner of the final meeting takes the first place, the loser - the second, the losing semi-final meeting takes third place. The places of the other athletes are determined in accordance with the round in which they finished the competition. Losers in the ¼ finals share from 5th to 8th place, they are not determined below the 8th place.

In weight categories in which the places were played out in a circular system, the winner and the winners are determined by the greatest number of victories, by the mutual meeting between the contenders for the same place, by the number of victories, by the least penalty points, etc.

To determine the winners and prize-winners in the unofficial team competition among the participating countries, the estimated indicators of athletes' personal results are established: I place - 8 points, II place - 5 points, III place - 3 points, 5-8 place - 1 point.

### **8. Awarding**

Champions and prize-winners are awarded with medals and diplomas.

The accreditation (entry fee) of each athlete at competitions for men and women is 50 USD

Athletes who have paid accreditation for participation in competitions in universal combat (light section) are exempt from the contribution to competitions in Unifight (classic section) and, accordingly, vice versa.

All teams should have with them two national flags and a national anthem on a CD for the opening, closing and awarding ceremonies.

### **10. Statements - protests**

A written protest statement may be filed in connection with a gross violation of the Universal Competition Rules or the presence of an extraordinary situation.

Applications-protests are filed in accordance with the requirements of the Universal Competition Rules.

The amount of the fee for the consideration of the application-protest is 250 US dollars and is paid by the party who submits the protest application along with the protest application itself. A protest without a fee is not considered.

In case of satisfaction of the protest application, the fee is returned to the party who submitted it.

In case of dissatisfaction with the application-protest, the fee is not returned and goes to the fund of the jury of the Cup.

### **11. Launch**

Participants who arrived according to the call are required to submit to the credentials committee through their representative or in person an application, documents proving their identity, as well as an insurance policy for each athlete.

### **12. Additional requirements**

Advertising during the World Cup with the permission of the Organizing Committee.
